

2019 CHAMBER ACCOMPLISHMENTS

GOVERNMENTAL AFFAIRS:

Advocating for our businesses is the Chamber's number one priority and meeting with our local, state and federal officials is the most effective means to accomplish that goal. Here are some highlights from this year:

EAST PARKER COUNTY DAY AT THE CAPITOL

Over 25 Chamber representatives traveled to Austin for East Parker County Day at the Capitol. The delegation met with stakeholders to discuss current issues impacting the community such as water, transportation and education.

WASHINGTON D.C. ADVOCACY TRIP

The Chamber's President and CEO, Lisa Flowers, joined North Texas businesses and civic leaders to Washington D.C. for North Texas Commission's Inaugural Advocacy Trip. The group met with lawmakers, administration and agency heads to advocate for business issues facing our region and to further promote the Commission's legislative priorities.

CHAMBER TAKES A STAND IN AUSTIN

The Chamber's Board of Directors approved a resolution in support of a version of House Bill 3 (HB3) that contains property tax relief as well as flexible school funding based on prior-year values that is not tied to performance on the STARR test. Members of the Chamber's Governmental Affairs Committee took a trip to Austin to talk with our State Representative Phil King and State Senator Pat Fallon about this bill. In addition, this group was able to voice their opposition to Senate Bill 29 (SB29) which would severely limit the ability of school districts, municipalities, and counties to advocate for their communities, tax payers, students, and employees.

CANDIDATE FORUM

In April 2019, the Chamber hosted a candidates forum for the contested races in Aledo, Annetta and Willow Park.





CHAMBER FOUNDATION:

In January 2019, the East Parker County Chamber of Commerce Foundation was organized as a not-for-profit 501(c)3 organization. The Foundation's purpose is to educate and assist the businesses of Parker County in disaster recovery. The eight member board of directors is currently working to build a base of funds so that when a disaster hits our fair county, we will be able to respond, rebuild, and recover.

MONTHLY LUNCHEONS

For many years, the Chamber has partnered with New River Fellowship in Hudson Oaks to host the monthly Chamber luncheons. An average of 160 members attend each luncheon and experience networking time, a catered lunch, business spotlights, a featured speaker, and a multitude of door prizes.

This year, surveys were handed out at a number of our events to find out topics of interest to our members. Luncheon programs ranged from a networking event, a first responders recognition, updates from county and city leaders, and speakers who specialized in improving business performance.



MEMBER ORIENTATIONS

Member orientations continue to be held each month to show new members how to set up their website directory listing as well as find the many ways to get connected through programs and events that will help them grow their business.

BUSINESS TO BUSINESS LEADS GROUP (B2B)

B2B is a group of professional men and women who meet over lunch in a friendly environment to build business success through personal referrals. This group meets two times a month to exchange qualified leads, build solid business relationships, develop presentation skills and become proficient networkers.



BUSINESS AND RELOCATION GUIDE

This year, the Chamber published its award winning Relocation and Business Guide seen by over 15,000 individuals. This 100+ page guide is printed in full color and will highlight the Chamber and its members, area schools, city offices, economic development, as well as editorials on the East Parker County area.

RIBBON CUTTINGS & GROUND BREAKINGS






